Fixed dollar discounts apply to siblings who are currently enrolled and attending Shire Christian School. The following discounts have been applied in the table above:

- Second child \$1,350 discount

- Fourth and subsequent children are entitled to a 100% discount^{1,2}



Payment Conditions

1. Fees are invoiced annually at the start of Term 1 Accounts must be paid in full by 30 November 2026.
2. Three payment options are available:
 - a. Full payment in advance with 2.5% discount
 - b. Payment Plan - direct debit instalments from February to November (interest free)
 - c. Payment plan with Edstart, a tuition fee funding provider

Details for each option are shown below.

Full payment in advance with 2.5% early payment discount

Payment is made through the Compass portal. You can make payments from:

- a bank account (no fees or surcharges apply)
- a credit card or debit card (a 1.85% surcharge will be added, VISA and MasterCard accepted)

The due date for payment in full to obtain the 2.5% discount is 15 February 2026.

Payment Plan - Direct debit instalments from February to November (interest free)

Payment plans can be set up by parents using the Compass portal. You can make payments from:

- a bank account (no fees or surcharges apply)
- a credit card or debit card (a 1.85% surcharge will be added, VISA and MasterCard accepted)

You can select to pay weekly, fortnightly or monthly from 1 February to 30 November and the portal will display the schedule of payment dates and amounts for the year.

The due date for establishment of a payment plan is 15 February 2026.

Payment plan with Edstart

Edstart is a tuition fee funding provider. They provide flexible payment plans that can incorporate not only tuition fees, but other education costs such as school uniforms, private tutoring, books etc.

Enrolment Conditions

One term's written notice of termination of enrolment is required. If not provided, one term's fees will be payable in lieu thereof.

The enrolment Confirmation Fee of \$1000 is non-refundable and is treated as fees in advance. It will be deducted from tuition fees when the student starts at the school.

The enrolment bond of \$1000 per family is paid when the first child's enrolment is confirmed and is repaid on request when the last child in the family leaves school.

Note that the enrolment bond or part thereof may be forfeited if school equipment (e.g. laptops and chargers), textbooks or library books are not returned when leaving the school, or if one term's written notice of leaving the school is not provided.

Sibling discounts do not apply to Prep fees.

School fees do not attract GST but other items may incur a GST charge.

The school has two tax deductible funds to which you may make a donation:

- Building Fund
- Library Fund

Donations to these funds would be greatly appreciated and tax-deductible receipts will be issued for all donations.
