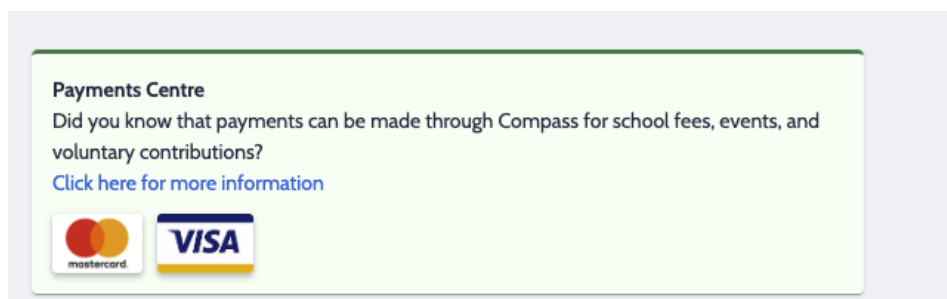


# Parent Guide: Paying Fees through Compass

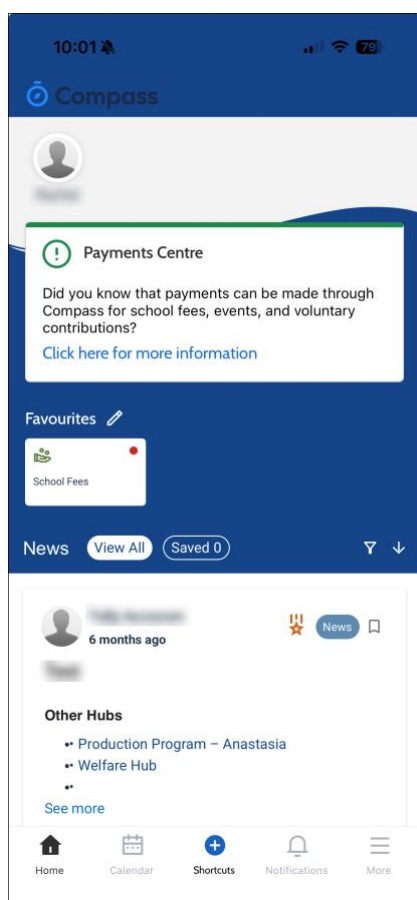
From 2026, school fee payment plans are created in Compass by parents. This guide will show you how to pay school fees and other charges through Compass.

Payment plans can be set up securely through the Compass Portal via a web browser on your computer or through the Compass app on your smartphone. For information about the security of the Compass payment platform, please see the notes at the end of this guide.

When you log in to Compass, a **Payments Centre** notification will be visible on the home page as shown below. To make a payment or to set up a payment plan, click the link in the notification window.



If you are using the Compass app on your smartphone, you will see the same **Payments Centre** notification on the screen. Tap on the link in the notification to continue.



After clicking / tapping on the link in the notification, the **Action Centre** screen will be displayed showing information about your school fees.

Click on the **2026 Tuition Fees and Levies** link as shown below.

The following window will be displayed explaining the options available for payment of tuition fees.

### 2026 Tuition Fees

Options for payment of fees are:

1. Payment in full by 15th February with 2.5% discount
2. Payment plan by direct debit

Please note:

- Payment plans must start in February and finish no later than the 30th November.
- Credit cards accepted: VISA and MasterCard.
- For payments from a bank account, please note the following requirements:

Payments from a bank account use the bank's PayTo process. Compass will send a payment request to your nominated bank account (using your PayID or BSB/Account number) and you must accept the agreement from within your banking app for the process to complete successfully. This process must be completed in one pass as there is a 10-minute time limit.

Your bank account must be a savings type account that supports PayTo agreements. Mortgage offset accounts cannot be used.

Due to bank transfer payment limits, if you intend to pay your fees in full from a bank account and your total amount to pay exceeds \$25,000 then you will have to make a direct bank transfer from your personal banking app. Please use the following details to make your payment.

Please note that due to bank transfer limits in our payment platform, there is a \$25,000 limit on single payments.

If you intend to pay your fees in full and the total amount to pay exceeds this limit, please click through to the next screen to make a note of the discounted amount to pay and then go to your personal banking app and make a direct deposit (transfer).

Enter your family name as the **payment reference** so we can identify your payment in our bank feed.

To set up payment by instalments, click **Continue** to proceed to the next screen.

If you have students enrolled in Secondary School, the next screen will display the *Student ICT Acceptable Use Policy* for the MacBook laptop program.

Please read and accept the agreement for each of your students and then click **Continue**.

If you do not have students enrolled in Secondary School you will not see the Agreements screen.

STUDENT ICT ACCEPTABLE USE POLICY  
MacBook Program 2026

This policy outlines the expectations, responsibilities and requirements for students in Years 7-12 participating in the school MacBook Program.

1. Acceptable Use

Students and parents must read and agree to this policy prior to receiving a computer device and using the school's ICT network. Students must follow all procedures outlined below when using their school-issued device.

2. Procedures for Use

2.1 Managing the Device

Students must:

Report any faults, damage or issues to ICT Services immediately.

Return the device to the school for any required service or repairs. Parents and students must not attempt to service or repair school-owned devices.

Keep device passwords confidential, except when shared with parents.

Take full responsibility for any activity performed under their login.

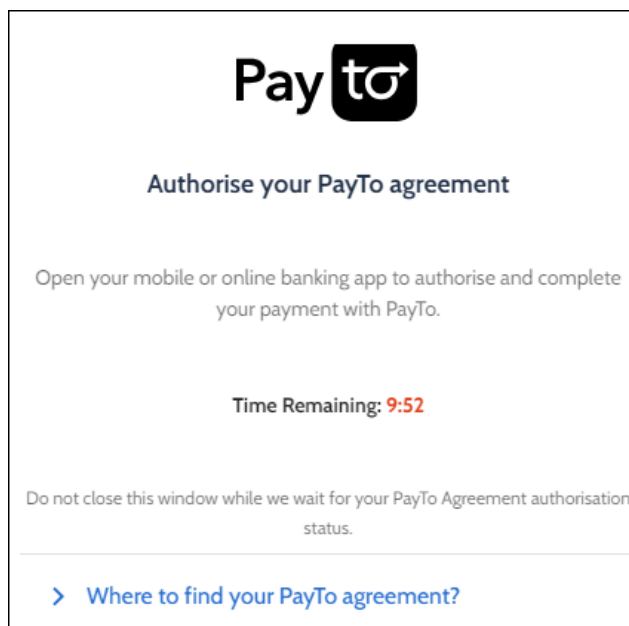

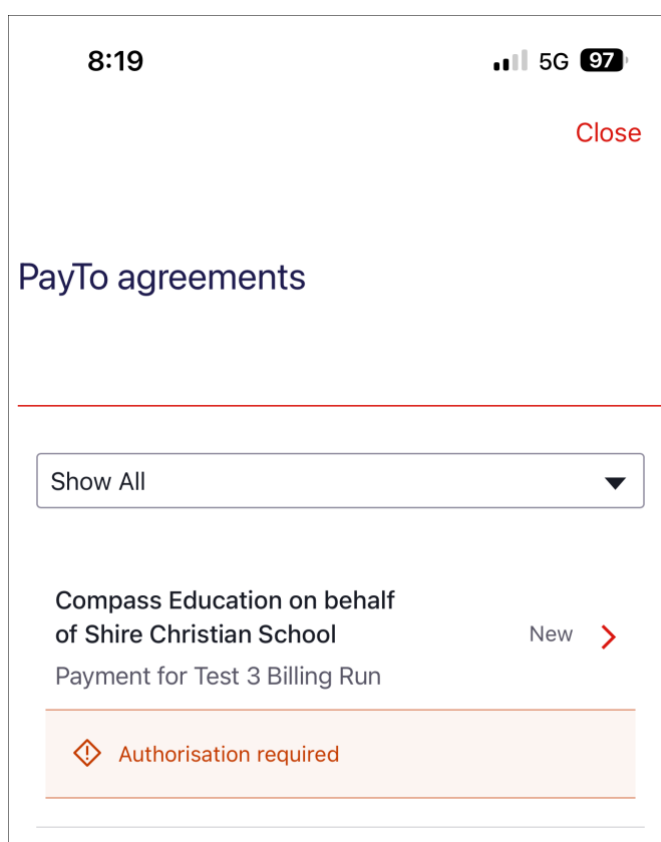
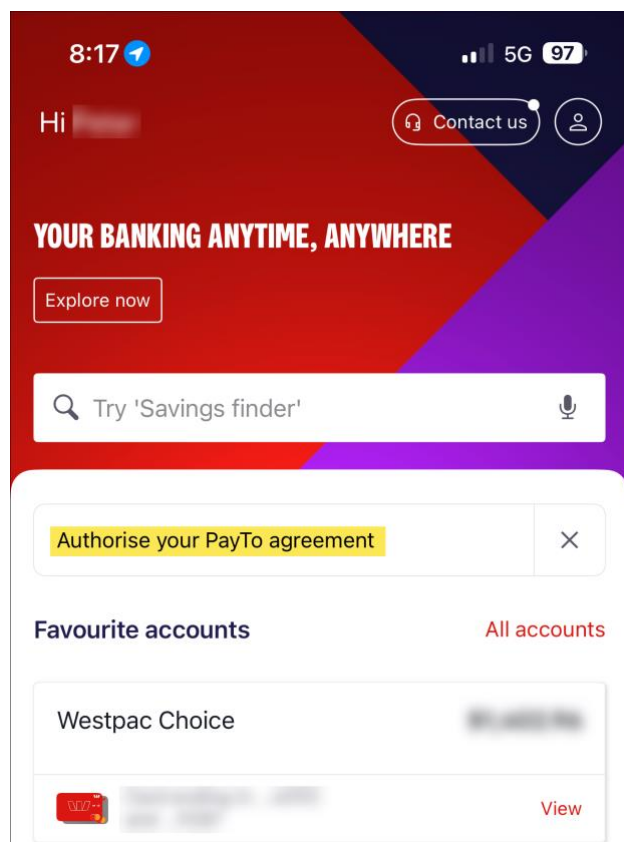

For PayTo agreements, after you click on the Process button the following screen will appear with a 10-minute countdown timer:



Note: The link “[Where to find your PayTo agreement?](#)” (shown in the screenshot shown) provides helpful guidance on where to find the **PayTo agreement** within your specific bank’s app.

The screenshots below show an example from the Westpac banking app. Your bank app may look different.



Locate the agreement in your banking app and authorise it. This authorisation will be communicated back to Compass within a few seconds.

Now go back to the Compass app and confirm the payment plan.

The Compass payment page will update in a few seconds and display a confirmation page and display your Instalment Summary:

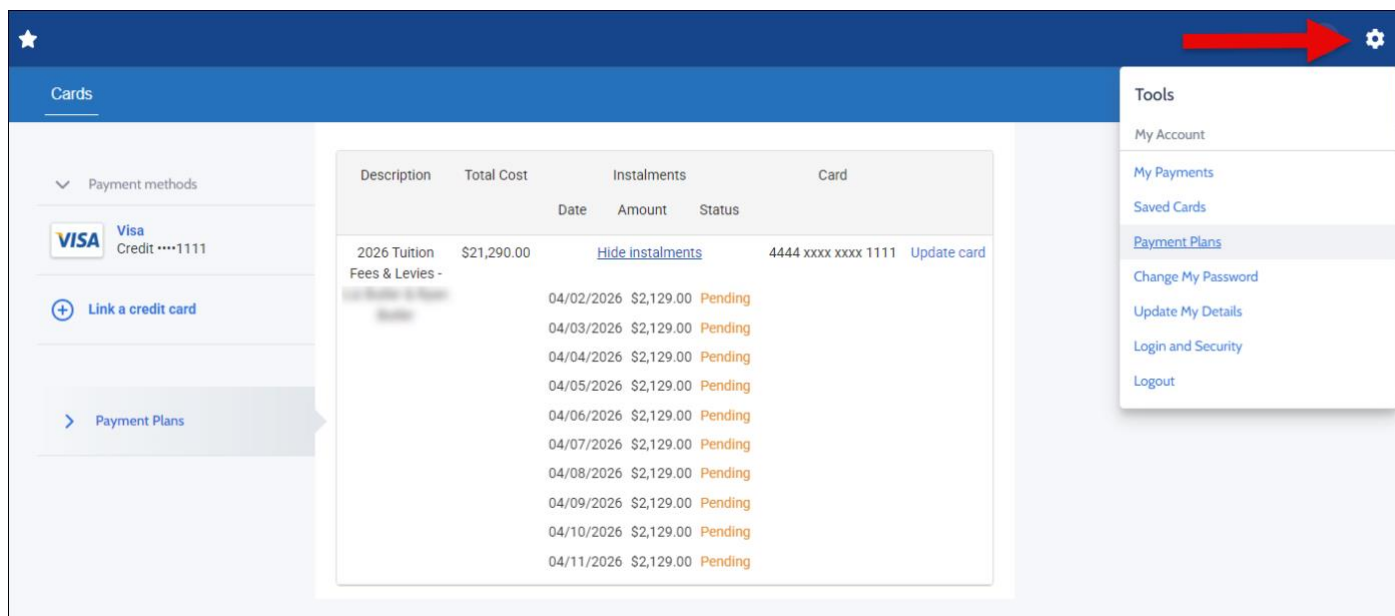
Payment instalments will be automatically processed by the bank on the dates displayed.

#### Important notes:

- Please ensure that you have sufficient funds available in your bank account or credit card account the day before the payment is scheduled to be processed. Payments are processed at 4:00pm on the scheduled day. If you have insufficient funds in your account, you will incur a rejected payment charge.
- Please contact the school at least 24 hours ahead of any scheduled payment if you do not have sufficient funds to make a request for delayed payment.

Click **Back to Action Centre** to exit from the Compass payment platform.

In the **Action Centre**, the cog icon at the top right-hand side of the screen provides access to several useful payment management features:

- **My Payments** shows previous payments made.
- **Saved Cards** displays credit cards you have saved on the system. You can add and remove credit cards using this feature and update card details.
- **Payment Plans** displays your current instalments including their paid/pending status.

### Security Information

The CompassPay platform is fully PCI DSS Level 1 compliant (Payment Card Industry Data Security Standard). This is the highest level available for a service provider. The system has undergone rigorous third-party testing and assessment to ensure the safe management of data consistent with industry regulations and standards.

All data is encrypted both in transit (using Transport Layer Security, or TLS 1.2) and at rest (using AES 128-bit encryption). This ensures that sensitive information, even when stored or being transferred, is protected.

Shire Christian School does not have access to bank account or credit card data submitted through the CompassPay platform.
